October 22, 2025 Meeting Minutes

At 5:33 p.m., Chairperson Carolyn Dawes called the meeting to order. Present were Commissioners Carolyn Dawes and Randy Mercier. Commissioner Jason Stephenson was absent. Also present was Jordan Knudsen, ex-officio member.

Members of the public present: none

Public Comment: none.

Randy moved to approve the minutes from the previous meeting of August 20, 2025, and Carolyn seconded. A voice vote was called, and the motion passed unanimously.

Outreach events:

Discussion on the outreach event of September 3 ,2025. Carolyn was happy about the event, but expressed that many of the comments were outside the scope of the commission. Carolyn noted that one person did raise concern on going to self-governing from the general powers. Carolyn and Randy both agreed that even though one person raised concerns, the self-governing still appears a good fit for Hardin.

Carolyn and Randy then discuss whether November 2026 should still be the date that the commission puts the matter on the ballot. Jordan said that the timeline could be amended, and that the topic should be placed on the agenda. Carolyn asked Jordan to put it on the agenda for the next meeting.

Discussion on website. Randy and Carolyn discussed the website. Carolyn asked if the commission should move forward on the website. After additional discussion, Randy and Carolyn agreed to proceed with the website.

Carolyn asked Jordan if the upcoming City Council elections would have any impact on the Commission. Jordan answered that they would not.

Randy asked if se should do any more outreach events. Discussion, and Randy and Carolyn agreed that if another outreach event, it should be limited to self-governing verses general powers. Jordan agreed this was a good idea.

Due to multiple absences, Jordan stated that he would try to reach out to Jason Stephenson to find out if he wanted to keep his position on the Commission, or if he had other thoughts about continuing.

The next meeting is scheduled for November 19, at 5:30 pm, according to Jordan.

Carolyn then moved to adjourn, and Randy seconded the motion. A voice vote was called, and the motion passed. The meeting was adjourned at 5:58 p.m.
